

Terms and Conditions for Awards given by Rediscovering Art by Women (RAW)

1 Purpose of the award

- 1.1 The award has been given for the purpose of funding a project by a contemporary artist that challenges the status quo and explores themes around identity, sexuality and gender.
- 1.2 The award is restricted for the purpose described in clause 1.1 and must be used for that purpose.
- 1.3 The award must not be used for any other purpose and must not be transferred to a third party.

2 Payment of the award

- 2.1 The total amount of the award is £5,000.
- 2.2 The award is payable in staged payments, comprising four quarterly payments of £1,250 each.
- 2.3 The first payment will be made on February 1st 2025 by electronic transfer.
- 2.4 Subsequent payments will be made on April 1st 2025, June 1st 2025 and August 1st 2025, subject to your compliance with these Terms and Conditions.

OR

- 2.1 [RAW will pay costs incurred in connection with the project (up to the total amount of the award) on submission of invoices to RAW, which RAW will settle directly with the suppliers. The list of anticipated costs and indications of when they will be incurred is set out in the Schedule. Any changes to the Schedule shall be communicated to RAW at the earliest opportunity.]

3 Spending the award

- 3.1 The award must be spent, wholly or partly, within 18 months of the date of the award letter which accompanies these Terms and Conditions.
- 3.2 Copies of receipts and/or invoices relating to award expenditure must accompany the award report described in clause 4.

4 Monitoring the award

- 4.1 Pursuant to RAW's Awards Policy, RAW will monitor the use of the award in a manner appropriate and proportionate to the nature of the award and the project for which it is given. In this case such monitoring will comprise quarterly meetings with one or more Trustees and/or members of the Selection Panel in which progress will be discussed as well as next steps.
- 4.2 Failure to comply fully with the above monitoring arrangements may result in continued payments pursuant to the award being jeopardised.

5 Publicising the award

5.1 Award recipients are encouraged to note RAW's support in appropriate published materials and RAW's logo shall be made available on request.

5.2 RAW may make information about the award given available to other bodies with a legitimate interest, such as professional advisors, other funders and statutory bodies. RAW may also use information about the award and its recipient in appropriate published materials.

6 Changes affecting the award

6.1 Award recipients are required to seek RAW's prior approval to any proposed changes to the use of the award given, including significant, substantive changes to the project.

6.2 Award recipients are required to inform RAW of any changes to their own circumstances which may affect the use of the award or the project for which it was awarded.

7 Reclaiming the award

7.1 RAW reserves the right to reclaim an award or part of an award if:

7.1.1 the project for which it was awarded does not proceed;

7.1.2 part of the award remains unused when the project that the award was intended to fund has been completed;

7.1.3 the award is used for a purpose other than that which has been agreed; or

7.1.4 compliance with these Terms and Conditions has not been observed.

7.2 RAW requires awards to be repaid if the award recipient is believed to have acted negligently or fraudulently or has ceased to operate in whatever circumstances.
